

WeProtect Global Alliance Policy Board Meeting

Summary, July 2022

The WeProtect Global Alliance Policy Board met on 11 and 12 July 2022. Nine Board papers were circulated in advance, presented at the virtual meeting, and discussed among Board members. The Board papers focused on:

- The Global Summit which took place in June 2022
- Survivor Engagement and Empowerment
- Strategy and Next Steps
- Model National Response and Government Engagement
- An investment case to tackle child sexual violence through the End Violence Fund

The European Commission's proposed legislation to prevent and combat child sexual abuse online was also discussed. The following actions and/or next steps were agreed upon with respect to each topic:

Global Summit

The Board noted positive feedback on the event and the growing levels of high-level commitment to the issue of child sexual abuse online. It also recognised the hybrid format as a success and recommended keeping this format in the future.

- The Board recommended prioritising financial commitments in future summits and increasing our level of engagement with survivors.
- The Board suggested considering options such as closed sessions and stronger facilitation to ensure greater opportunities for audience participation. A formal dinner or extending the event to three days were also proposed by the Board as ways to increase engagement.
- The Secretariat will integrate the Board feedback (along with wider attendee feedback) into lessons learned to inform planning for the next Board.
- The Secretariat will follow up with the UAE to offer any assistance in outreach to prospective or current members.

Survivor Engagement and Empowerment

The discussion revolved around the commitment taken by the Board at their last meeting to add to the Board an adult survivor of child abuse. According to the paper on Survivors Engagement and Empowerment, among other criteria, the Board representative should be an adult survivor of online child sexual abuse and belong to a member organisation of the Alliance.



Bringing together experts to protect children from sexual exploitation and abuse online

- The Board concluded that it is important to separate the issues of participation by children and young people and that of survivor participation.
- The Board, while recognising the Alliance's continuing online focus, recommended that the Secretariat should not exclude consideration of survivors of offline child sexual abuse.
- The Secretariat will update the criteria and initiate the selection process.
- The Secretariat will share a recommendation for an additional Board member with the Board by email ahead of the December Board meeting.

Strategy and Next steps

The discussion revolved around the strategy paper, which proposes the direction of travel for the three-year strategy.

- The Board noted this was a time of extremely stretched budgets and competing priorities for donors. Consideration should be given to "nesting" child sexual abuse online within wider forms of harms while maintaining our own focus and unique added value.
- The Board members will volunteer for the Strategy Working Group or nominate others.
- The Secretariat should proceed with consultation on the proposed outcomes and vision as set out in the paper, making use of reference groups and other opportunities for consultation.

European Commission's proposed legislation to prevent and combat child sexual abuse online

Board member Antonio Labrador Jiménez from the European Commission briefed the Board on the proposed EU Child Sexual Abuse legislation.

- The Board discussed the media strategy of the legislation.
- The Board highlighted the importance of ensuring the conversation around legislation remains global to avoid regulation that underpins local working arrangements ending up with duplication of processes or creation of gaps.
- The Secretariat will consider ways to make EU advocacy-related material more obvious on the website, creating a user-friendly hub.
- The European Commission will keep the Board and Secretariat updated on progress and ask for any assistance required.

Model National Response and Government Engagement

The discussion considered the establishment of the Global Task Force (GTF) to drive government participation, focusing on the Model National Response.



- The Board highlighted the need to build engagement through civil society and the private sector as well, particularly in those regions where we had fewer members
- The Secretariat will liaise with ECPAT on contact details to approach Mozambique authorities on Alliance membership.
- The Secretariat will take forward the approach outlined in the paper.

An investment case to tackle child sexual violence through the End Violence Fun

The Board member Howard Taylor from the Global Partnership to End Violence Against Children (EVAC) presented the EVAC/Dalberg work on a business case to raise \$1 billion for child sexual violence, aiming to impact as many as 14 million children.

The Board agreed that EVAC should keep the Secretariat up to date with developments.
